Dear Residents,

On June 15th, Governor Cuomo announced that New York State has achieved the 70% adult vaccination threshold and that most COVID-19 restrictions have been lifted based on data from the CDC.

This is exciting news, and as our region continues to reopen, we are working through what that means for our pool and park facility. We will be sharing information regarding our updated guidelines in the coming days.

As always, our top priority is to ensure the health and safety of our staff and residents. We will be following the regulations required and recommended by the Nassau County Department of Health, NYS, and the CDC. Keep in mind these guidelines are being updated daily. We will continue to review and modify protocols as restrictions lessen.

Please take note of the following adjusted guidelines:

- There is no capacity limit for open swim sessions.
- Effective JUNE 15th, no masks will be required in outdoor spaces. In indoor shared spaces, not fully vaccinated individuals are expected to wear mask and follow mask requirements per CDC, NY State, and Nassau County. All members are welcome to continue wearing a mask if they feel more comfortable in doing so.
- Indoor showers will be serviced and ready for use by **JUNE 26th**
- The pool will be open **FULL TIME** starting **JUNE 21st** from 9am to 7:30pm
- Pool Sessions
 - 9am-10:30am** lap swim (2x45-min sessions)
 - 10:30am- 11:15am** (Starting **June 28th** M-F shared lap lanes with camp instructional swim. Weekends and non camp days this will remain a 45-min lap swim only session)
 - 11:15am-5:00pm** open swim
 - 5:00pm-7:30pm** open swim with shared lap lanes
- Lap swim
 - Multiple people per lane are permitted; 6 lanes per session (except the shared evening and morning sessions)
 - Sessions are 9-9:45, 9:45-10:30, 10:30-11:15. **Please abide by these time slots in order to ensure access for all residents**
- The Concession "Shack" will be open **JUNE 24th** from 12pm to 7:30pm. Hot food will be served starting **JUNE 26th**.

The following guidelines continue to be in effect:

- No guests allowed. We are anticipating allowing guests but need to consider local guidelines and establish an appropriate and fair protocol for the check-in process.
- ALL residents (adults and **children of ALL ages**) **MUST** present a **VALID** park card for entry
- An outdoor shower on the deck is available before and after pool use (**NO soap permitted**)
- In the event of inclement weather, we are still asking residents to return to their vehicles. We will announce what time the pool plans to reopen, and residents can call 516-862-8657 or 516-482-2266 to check if that time has been adjusted based on weather conditions.
- The parking lot is restricted to residents whose cars display a "**GNE**" sticker. If you require a new sticker, please contact GNE Police 24/7 at 516-487-7700.
