Our **2023** season opens **Saturday, May 27<sup>th</sup>**. The pool will be open **4:00pm –7:00pm WEEKDAYS** and **10:00am –7:30pm WEEKENDS**, until Father's Day (June 18<sup>th</sup>). From **June 19<sup>th</sup> through Labor Day** the pool will be open **EVERYDAY** from **10:00am – 7:30pm**.

## Please review the enclosed Rules and Regulations.

The pool is temperature controlled at 80° and we are continuing to upgrade and improve the facilities. We invite you to enjoy the summer at the park with your family and friends. If you should have any questions about your membership or park regulations, please do not hesitate to call Village Hall (482-8283).

**Guests** may use our pool and/or tennis facilities, **only** if accompanied by a resident, subject to payment of a daily guest fee at the admission desk or with a **pre-paid discounted guest FUNpass, available at Village Hall**. Any unused portion of last summer's FUNpass may be used this season.

Plan to visit our **Concession** featuring kosher foods. A pre-paid **FOODpass** is available at the **Concession Stand** which offers a 20% discount on purchases. **Please note the FOODpass expires at the end of this season.**

**Parking Regulations** The parking lot at Great Neck Estates Park is restricted to vehicles of Great Neck Estates residents **ONLY** which display a silver **RFID (Radio Frequency Identification)** sticker issued by the Great Neck Estates Police Department. The RFID sticker will raise the automatic arm at the entry gate allowing entrance to the park. Without a new parking pass your vehicle will not be allowed entry. 
